- e. All frozen semen remains the property of Tweedie & Associates Equine Veterinary Services and any unused semen must be returned to Tweedie & Associates Equine Veterinary Services at the purchasers expense by 1 April 2012.
- f. There is no pregnancy or Live Foal Guarantee.
- g. A completed application for service certificate must be received by Tweedie & Associates Equine Veterinary Services before a service certificate will be issued. The purchaser is responsible for providing this form to Tweedie & Associates Equine Veterinary Services.
